Tokio Marine Holdings Selected as an "A-list Company" by CDP

Tokio Marine Holdings, Inc. (President and Group CEO: Satoru Komiya, hereinafter "TMHD") has been selected as an "A-list Company" for the second consecutive year, the highest rating in the climate change survey by the international environmental not-for-profit charity CDP*1.

*1 CDP: An international environmental not-for profit charity (headquartered in London) that has a system for environmental information disclosure. Its main activities include requesting companies and local governments to disclose information on climate change measures and promoting climate change measures. (www.cdp.net)

The evaluation process for environmental information disclosure by CDP is widely recognized as the global standard for corporate environmental information disclosure. In fiscal year 2024, over 24,800 companies worldwide disclosed information to CDP, and in Japan, more than 2,100 companies, including over 70% of the companies listed on the Prime Market, have responded to the survey.

Companies are evaluated based on their responses regarding their efforts to address climate change and are assigned scores ranging from A to D-.

Based on our purpose, Tokio Marine Group positions climate action as a material issue (materiality) we must address as a global company. To achieve net zero by 2050, we have been working on engaging with our customers and providing insurance products and services that support our customers' transition towards decarbonization.

To further promote our initiatives to tackle climate change in relation to insurance underwriting, Tokio Marine Group has set a group-based interim target for transition products/services in September 2024*2, in addition to an interim target for client engagement set previously by Tokio Marine & Nichido Fire, our main non-life insurance company in Japan.

Tokio Marine Group as a whole has achieved carbon neutrality*³ for 11 consecutive years since 2013 through initiatives such as mangrove tree planting.
